

NOTICE TO BIDDERS

Sealed Bids for **Sealed Bid Number SB13-179** will be received by the St. Charles County Purchasing Manager, 201 North Second Street, Suite 541, St Charles, Missouri 63301, Until 10:00 A.M., (prevailing Central Time) on December 17, 2013 and will thereafter be publicly opened and read aloud in Conference Room 431.

The proposed work includes the furnishing of materials, tools, equipment and labor necessary to construct **Central School Rd. at Highfield Dr. Traffic Signal Installation** in St. Charles County, Missouri.

The construction shall include all work incidental to the furnishing of materials, tools, equipment and labor necessary to construct the proposed traffic signal, demolition, removals, sidewalk, ADA ramp, traffic signal roadway lighting, concrete curb/gutter, concrete bases, underground electrical conduit/cables, signage, pavement markings, various equipment programming services, and other appurtenances in St. Charles County, Missouri.

Plans and specifications may be obtained on and after November 14, 2013 for a **\$50** non-returnable fee at the office of the St. Charles County Highway Department, 201 N. Second Street, Suite 429, St. Charles, Missouri. Sets will be mailed upon request for a non-returnable fee of **\$80** after a check is received. Make all checks payable to "**St. Charles County Highway Department.**"

Each Bid must be accompanied by a Cashier's Check or Certified Check, or a Bid Bond executed by the Bidder and an approved Surety Company and payable to the County, in an amount not less than Five Percent (5%) of the Sum Total of the Base Bid.

Not less than the prevailing hourly rates of wages as found by Federal Wage Rates, or determined by court on appeal, shall be paid to all workers performing work under this Contract. Missouri Annual Wage Order 20 shall be in effect for this project.

The DBE goal for this letting is a minimum of **10%** of the total contract amount.

TRAINEES: No trainees or trainee hours will be required under this contract.

All contractors and subcontractors are subject to and must comply with the Safety Program Training requirements of Section 292.675 of the Revised Statutes of Missouri.

All requests for clarifications on these bidding documents must be received in writing at least one week prior to the bid opening.

All bidders must meet the MoDOT requirements as a CONTRACTOR at least seven (7) days prior to bid opening in accordance with Section 102.2 of the St. Charles County Standard Specifications for Arterial Highway Construction.


A Performance Bond and Payment and Materials Bond are required.
