The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L.87-581; 76 Stat. 357) and implementing regulations. The higher of the Federal or State Wage rates shall apply.

A prime contractor must have a fully responsive contractor questionnaire on file with the Missouri Highways and Transportation Commission (MHTC) at least seven (7) days prior to the bid opening date.

Bidders are required to submit the corresponding documentation of enrollment in the E-Verify program. This documentation includes the Memorandum of Understanding between the company and Department of Homeland Security and the Affidavit of Compliance. MoDOT will accept the first page and the signature page of the agreement as proof of participation.

Missouri law, 292.675 RSMO, requires the Contractor and its subcontractor(s) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement).
