The south side of 26th Street from Wisconsin Ave. to Vermont Ave., along the north side of 28th Street from Wisconsin Ave. to Vermont Ave., along the east side of Kansas Ave. from 26th St. to 27th St. and along the west side of Kansas Ave. from 28th St. to 30th St.

Sealed bids for Kelsey Norman Sidewalks, Federal Project No. STP 3200-(715), will be received at the office of the Director of Public Works located at City Hall, 602 S. Main Street, Joplin, Missouri 64801 until 10:00 o'clock A.M. (Prevailing Local Time) on the **24th day of October, 2013**, in the basement conference room, and at that time will be publicly opened and read. All bids shall be submitted sealed, addressed to the Director of Public Works, 602 S. Main Street, Joplin, Missouri 64801.

Plans and specifications may be picked up from the office of the Director of Public Works at City Hall, 602 S. Main Street, Joplin, Missouri.

A mandatory pre-bid conference will be held at 10:00 AM on the 17th day of October, 2013, at the same location.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The **City of Joplin, Missouri** hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Joplin reserves the right to reject any or all bids.

No 2nd tier subcontracting will be allowed on this project.
