and endorsed "Proposal" for constructing (or improving) Bridge No. 10100071, BRO-B024(22) Clay County, Missouri, will be received by the Clay County Purchasing Agent until 2:00 o'clock P.M. (Prevailing Local Time) on the 26th day of September, 2013, at the office of the 3rd Floor Commission Hearing Room at Liberty, Missouri and at that time will be publicly opened and read.

The proposed work includes:

Clay County Bridge No. 10100071 Clay County Bid No. 29-13

Construction of a 106.1' long, 26.7 foot wide, three-span, concrete I-girder bridge including roadway improvements.

This is a prevailing wage project. The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. State wage rates, not Federal wage rates, are to be utilized for this contract. Certified payroll for each employee must be submitted and approved on a weekly basis.

The County of Clay hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. The Disadvantaged Business Enterprise (DBE) Goal for this project is 9%.

Enrollment in Federal Work Authorization Program – Bidders are informed that, pursuant to Section 285.530 RSMo., the successful bidder shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection to the contracted services.

Safety Training Program – Bidders are informed that the project is subject to the requirements of Section 292.675 RSMo., pertaining to on-site employees completing a course in construction safety and health approved by the Occupational Safety and Health Administration (OSHA).

MoDOT Pre-Qualification Requirements - The Prime Contractor shall be required to meet the MoDOT pre-qualification requirements for this project. See Section 102 of the Missouri Standard Specifications for Highway Construction and the Engineering Policy Guide, Section EPG 136.9.4.1.1.14.2.1 for pre-qualification requirements.

No 2nd tier subcontracting will be allowed on this project.
