

NOTICE TO BIDDERS

Sealed bids subject to the conditions and provisions presented herein will be received until 2:00 PM on September 4, 2013, and then publicly opened and read at the Caruthersville City Hall, 200 West Third Street, Caruthersville, MO 63830, for furnishing all labor, materials, equipment and performing all work necessary for replacement of the existing runway lighting fixtures and wiring and installation of new fencing.

Copies of the bid documents including project drawings and technical specifications are on file and may be inspected at the Caruthersville City Hall and at the office of the Engineer, Waters Engineering, 908 South Kingshighway, Sikeston, MO 63801.

A complete set of bid documents may be obtained from the office of the Engineer, Waters Engineering, 908 South Kingshighway, Sikeston, MO 63801 for a non-refundable fee of \$100.

No prebid conference for this project will be held.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to City of Caruthersviller, Missouri.

Bids may be held by the City of Caruthersville for a period not to exceed 90 calendar days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as the City of Caruthersville may require, to reject any bid and also the right to reject all bids.

In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in accordance with the schedule of wage rates established by the United States Department of Labor and the Missouri Division of Labor Standards, respectively. The highest rate between the two (Federal and State) for each job classification shall be considered the prevailing wage.

This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise Participation. The owner has established a contract goal of **ZERO** percent participation for small business concerns owned and controlled by qualified disadvantaged business enterprises (DBE). The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet the established goal.
