

INVITATION TO BID

RECEIPT OF BIDS

Sealed bids for the construction of Downtown Revitalization Project Phase IIIB will be received for the City of Warrensburg, Missouri, represented by Department of Public Works, City Administrator.

Bids will be received at City of Warrensburg Office of the City Clerk located at 102 S. Holden Street, Warrensburg, MO 64093 until 10:00 a.m. on August 30, 2013, and shortly thereafter, the bids will be opened publicly and read aloud in the Municipal Building located at 200 S. Holden Street, Warrensburg, MO 64093.

GENERAL DESCRIPTION OF WORK

Streetscape project consisting of approximately 75 TON of 2" asphalt surface course, 514 LF of curb and gutter, 721 SF of brick pavers, and 2,560 SF of concrete sidewalk. Work also includes but is not limited to tree and tree grates, storm sewer, sanitary sewer, street lighting, and traffic control.

Bids shall be on a unit price basis.
