Notice to Contractors

Sealed bids for the "Proposal for the Construction of Hickory County Bridge 11900151, BRO-B043(9)" will be received at: Hickory County Commission, Hickory County Courthouse, Hermitage, MO 65668 until 10:00 o'clock A.M.(Prevailing Local Time) on the 22nd day of August, 2013 at the office of the Hickory County Commission, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes: Construction of a double-span, 110-foot long pre-stressed I-Girder bridge, approach roadway work and any incidental work in accordance with the plans and specifications. The project is located on County Road 340, in Sections 3 & 34, Townships 35N & 36N, Range 23W, Hickory County, Missouri, over Weaubleau Creek. The total length of the improvements is approximately 632 feet.

Plans and specifications may be picked up on a CD for printing by the bidder or in hard copy format from the office of Great River Associates, Inc. at 2826 South Ingram Mill Road, Springfield, Missouri 65804 upon payment of \$50. For plans and specifications mailed to bidders \$25 will be added for postage and handling or the bidder may provide a FedEx account number. Purchase and postage amounts are not refundable. All bidders must be on the Great River Associates planholder list.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations Annual Wage Order 20.

The Hickory County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Hickory County Commission reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsive, responsible bidder.

The DBE Goal for this project is 5%.

No 2nd tier subcontracting will be allowed on this project.
