NORTH INDEPENDENCE BRIDGE IMPROVEMENT PROJECT

Will be publicly opened and read aloud. The work under this Contract consists of the following:

Demolition of existing bridge, and construction of new metal arch structure including reinforced concrete footings, headwalls, and wing-walls; roadway widening; storm drainage pipes; inlets; junction structures; sidewalks; guardrails; curbs; grading; asphalt; and other miscellaneous features including traffic control, erosion control, and site restoration.

All equipment, material and workmanship must be in accordance with the Plans, Specifications and other Contract Documents in the Project Manual on file with the City of Harrisonville, Missouri. All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Harrisonville hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award." All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project. No 2nd tier subcontracting will be allowed on this project

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal. The DBE Goal for this project is 10%.

The City reserves the right to accept or reject any or all bids and to waive any technicalities, irregularities or informalities therein, and to award the project to the lowest, responsive, responsible bidder. Bid may be modified or withdrawn by written request of the bidder received in the office of the City Clerk, prior to the time and date for bid opening.
