The *General Services Department* of Kansas City, Missouri will receive sealed Bids until 2:00 PM, on July 9, 2013 at 414 E 12th Street, 1st Floor, Room 102W, City Hall, Kansas City, Missouri, 64106 for **Project No. 89060340, SRTS-INF H284(105) NE 48th Street Sidewalk – Safe Routes to School.** Bids will be opened after that time at the same location.

Bidding Documents will be available online to all interested parties at the Kansas City, Missouri Plan Room, <http://www.kcmoplanroom.org>. All addenda will be posted at this location. Any document or plan may be viewed or downloaded from this location.

The proposed work includes the construction of a sidewalk along the south side of NE 48th Street from Vivion Road to Antioch Road in Kansas City, Clay County, Missouri.

This project is funded in part with funds offered by the Missouri Department of Transportation (MoDOT). The City of Kansas City, Missouri, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Prior to Bidding, Subcontractors utilized for DBE Goals must appear on the MoDOT/Kansas City Approved DBE List and on the MoDOT DBE Directory located at http://www.modot.mo.gov/business/contractor_resources/bid_opening_info/bidGenInfo.shtml. The DBE goal for this project is 12%

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial relations (Federal Wage Rate), or state wage rate, whichever is higher.

Sec 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition will be waived for this project.

Each bidder must certify that it is not presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from covered transactions by any federal agency.

Bid security in the amount of 5% of the bid price shall be submitted with each bid.

The contract will be awarded to the lowest, responsive, responsible bidder.

A **Pre-Bid Conference** will be held on Monday, July 1st, 2013 at 10 a.m. in the main conference room at the Municipal Service Center located at 5300 Municipal Avenue, Kansas City, Missouri 64120. Attendance at the pre-bid conference is encouraged for all Bidders on this Project.
