Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to City of Cape Girardeau.

Bids may be held by the City of Cape Girardeau for a period not to exceed sixty (60) days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as the City of Cape Girardeau may require, to reject any bid and also the right to reject all bids.
