The major proposed work includes: Streetscape improvements including replacement of 21,002 square feet of 4" thick concrete sidewalk with brick accents and ADA compliant ramps with detectable warning inserts, 4,020 lineal feet of new concrete curb and gutter, construction of center medians, 283 lineal feet of asphalt edge milling, 750 tons of new asphalt overlay 2" nominal thickness, storm drainage improvements, 22 new decorative street lights, related electrical work, sodding and surface restoration.

A certified check on a solvent bank or a bid bond by a satisfactory surety in an amount equal to five percent of the total amount of the base bid must accompany each proposal, and shall be considered the Bid Security.

The successful bidder shall at the time of the execution of the Contract furnish separate performance and payment bonds in a sum equal to the Contract price payable to the City of Kirksville, Missouri, and shall be considered Contract Security.

All Bidders must be on MODOT's qualified contractor list per section 102.2 of the Missouri Standard Specifications for Highway Construction 2011 Edition including all revisions. The Contractor questionnaire must be on file 7 days prior to the bid opening. No Bidder may withdraw his bid within 60 days after the actual date of the opening thereof.

The project will be awarded to the lowest, responsive, responsible bidder. No award is final until formally approved by the City Council, MODOT and the FHWA.

All proposals arriving at the designated office after the deadline specified will not be considered and will be returned unopened.

All wages paid for work under this contract shall comply with requirements of the prevailing wage law of the State of Missouri (MO Public Law 294, Section 290.210 through 290.340 and Section 290.550 through 290.580, as amended RSMo 1969).
