**INVITATION TO BID**

Sealed bids for **CITY OF WEST PLAINS, MISSOURI – SAFE ROUTES TO SCHOOL** will be accepted at the City of West Plains, 1910 Holiday Lane, West Plains, MO 65775, until **10:00 A.M., Local Time, on Tuesday, April 16 2013**, and then publicly opened and read aloud. Bids received after 10:00 am will be returned unopened.

Project will consist of sidewalk improvements within the 100-600 blocks of North Howell Ave. as the Base Bid. It also includes Alternate Bids 1 & 2 lying within blocks 600 and 700 of East Olden Street and the 300 block of East Third Street, respectively. The work will involve removal of improvements, reconstruction and new construction of sidewalks including ADA ramps, fencing, storm water improvements and restoration of areas surrounding the construction work.

Copies of the drawings, specifications and other proposed contract documents must be obtained from the Engineer at the office of City Hall, 1910 Holiday Lane, West Plains, Missouri 65775. Any bid received from a contractor whose name does not appear on the list of plan holders at the Office of City Hall, will be subject to rejection. Suppliers and Subcontractors will be classified as Non-Bidders.

Each bidder shall file with his bid a cashier's check, certified check, or a bid bond in the amount of five percent (5%) of the total bid made payable to the City of West Plains, Missouri.

The bidder to whom a contract is awarded will be required to furnish a contract bond on the forms provided, acceptable to Owner, in the amount of 100 percent of the contract price in conformity with the requirements of the General Conditions.

The Bidder shall submit a list of subcontractors as specified in the bid documents with its bid.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. The higher of the State and Federal wage rates shall prevail.

The successful Bidder shall comply with certain insurance requirements as specified in the bid documents.

The City reserves the right to reject any and all bids for reasons outlined in the Missouri Standard Specifications for Highway Construction, 2011 Edition, including all revisions. The bid will be awarded to the lowest, responsive, responsible bidder. The lowest bid will be the lowest of the base bid and alternate 1 combined.

Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition, will be waived for this project. Non-MoDOT approved contractors are allowed for this enhancement project.

MoDOT and FHWA shall have the right to inspect work.

Second tier subcontracting will not be permitted on the project.
