When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. The higher of the State and Federal wage rates shall prevail.

The successful Bidder shall comply with certain insurance requirements as specified in the bid documents.

The City reserves the right to reject any and all bids for reasons outlined in the Missouri Standard Specifications for Highway Construction, 2011 Edition, including all revisions. The bid will be awarded to the lowest, responsive, responsible bidder.

Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition, will be waived for this project. Non-MoDOT approved contractors are allowed for this enhancement project.

MoDOT and FHWA shall have the right to inspect work.

Second tier subcontracting will not be permitted on the project.
