

**Sidewalk Project  
Notice to Contractors**

Sealed bids for Sidewalk Improvements for Federal Project STP-9900 (733) will be received at City Hall, 1424 South Street, Stockton, MO 65875 until Two o'clock (2:00) P.M. on the 31st day of January, 2013, at the office of the City Clerk, and at that time will be publicly opened and read.

The proposed work includes a Base Bid and an Alternate Bid:

**Base Bid: Route 39 consists of grading, drainage, pedestrian signing & crossings and the construction of an 8 feet wide multi-use sidewalk along the east side from the Elementary/Middle School campus 3,881 feet to the High School campus.**

**Alternate Bid: Route 32 consists of grading, drainage, curb & gutter, driveways and a 5 feet wide sidewalk easterly along the north side along the City Cemetery 589.5 feet to Route J entirely within MoDOT right of way. In addition, this section includes a disconnected section 69 feet along the west side of North Street in front of the City Community Center.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Stockton hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Stockton reserves the right to reject any or all bids. The project will be awarded to the lowest, responsive, responsible bidder.

The DBE Goal for this project is 6%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
