All equipment, materials and workmanship must be in accordance with the drawings and specifications on file with the City Clerk, Winfield, Missouri and in the office of the Consulting Engineers, Shafer, Kline & Warren, Inc., 3200 Penn Terrace, Suite 100, Columbia, Missouri 65202.

Copies of the bidding documents (Invitation to Bid, Notice to Contractors, Bid form, Contract Agreement form, Performance Bond and Payment Bond forms, General Conditions, Job Special Provisions, Technical Specifications, and Drawings) desired for bidding purposes may be obtained on-line from the Drexel Technologies Planroom at www.drexeltech.com (913-371-4430) at a non-refundable charge of \$60.00 per printed set or \$30.00 for electronic files.

A certified check on a solvent bank or a bid bond by a satisfactory surety in an amount equal to 5% (five percent) of the total amount of the base bid must accompany each proposal as bid security.

All forms with footer marked as "BID FORM SUBMITTAL" shall be included with the sealed bid.

No Bidder may withdraw his bid for a period of 60 days after the date of opening of bids.

This project does not include any bridge or roadway work; therefore, Section 102.2 of the Missouri Standard Specifications for Highway Construction (<u>http://www.modot.mo.gov/business/standards_and_specs/Sec0102.pdf</u>) will be waived for this project allowing non-MoDOT contractors.

As a condition for the award of any contact in excess of five thousand (\$5,000) the bidders shall supply with their bid a sworn affidavit and documentation affirming its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. Bidder shall also supply a signed affidavit affirming that it does not knowingly employ any person who as an unauthorized alien in connection with the contracted services.

If this contract involves the construction, reconstruction, demolition, painting, or major repair of any facility of the City, Bidder shall provide a ten (10) hour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees within 60 days of award of the contract. Failure to provide training and maintain documentation of the training, may result in penalties under RSMO 292.675.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962" (P.L. 87-581; Stat. 357) and implementing regulations.

The City of Winfield hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

A Disadvantaged Business Enterprise (DBE) goal of 4% has been established for this project.
