# **MISCELLANEOUS**

M-1: Asphalt pavement in lieu of limestone screenings will not be considered for Phase 1 trail, or trail north of Oak Street.

M-2: No priority will be given on which section of trail, Phase 1 or downtown, is to be constructed first. As stated in JSP 098, the Contractor is required to submit a traffic management schedule for approval before any work can be started.

### **PROJECT MANUAL**

PM-1: DBE Goal - The Goal is set at 12%, applied to the base bid only. Add alternates will not be included in the DBE percentage. If the bidder does not meet the established project DBE goal, award of contract can only be made if the bidder can document and demonstrate a good faith effort to meet the goal. MoDOT will review and make a determination of the good faith effort.

PM-2: Bid Form - Replace the Bid Form located within the Project Manual with attached Bid Form 2. Modifications have been made to the Itemized Proposal and to page B-4 Proposal Quantities.

- failure to comply with any material provision of the contract
- third party claims filed or reasonable evidence that a claim will be filed
- failure to make timely payments for labor, equipment or materials
- damage to a contractor, subcontractor or material supplier
- reasonable evidence that a subcontractor or material supplier cannot be fully compensated under its contract with the contractor for the unpaid balance of the contract sum
- citation by the enforcing authority for acts of the contractor or subcontractor which do not comply
  with any material provision of the contract and which result in a violation of any federal, state or
  local law, regulation or ordinance applicable to that project causing additional costs or damages
  to the owner.

In submitting this bid, the undersigned declares that it is of lawful age and executed the accompanying bid on behalf of the bidder therein named, and that it had lawful authority so to do. ### **SECTION 121 – CONCRETE PAVEMENT AND BASE**

Concrete Pavement and Base shall be installed where indicated on the contract drawings or by the Owner's Representative. Concrete Pavement and Base shall conform to and meet the requirements of Division II, Section 2200 Paving and all related subsections, and Trail Standards of the Kansas City Metropolitan Chapter of the APWA, latest edition.

Concrete Pavement for Phase 1 Trail shall be 4-inch depth non-reinforced and shall meet the requirements of Specification Section 2208.2 for paving. Base shall be a 4-inch depth MoDOT Type 5 aggregate. Refer to Sheet A300.

Concrete Pavement for Downtown Plazas shall be 6-inch depth reinforced and shall meet the requirements of Specification Section 2208.2 for paving. Base shall be a 4-inch depth MoDOT Type 5 aggregate.

Method of Measurement: 4" depth Concrete Pavement and Base shall be measured per square yard or tenth part thereof for the specified depth accepted and shall include materials and all other equipment and personnel necessary to construct and complete installation as intended by the Plans and Specifications.

6" depth Concrete Pavement and Base shall be measured per square yard or tenth part thereof for the specified depth accepted and shall include materials and all other equipment and personnel necessary to construct and complete installation as intended by the Plans and Specifications.

Basis of Payment: The accepted quantity shall be paid for at the contract unit price, measured as stated above. Such payments shall include the whole cost of providing all labor, tools, equipment, materials, handling, storage, hauling, disposing and any other requirements and sundries associated with this item.
