



NOTICE TO CONTRACTORS

and endorsed "Proposal STP-5401(661)" for Clayton Road Pedestrian Improvements from Woods Mill Road to Old Woods Mill Road, City of Town & Country, Missouri, will be received by the City **until 10:00 AM (prevailing local time) on December 27th, 2012**, at the City Clerk's Office, City of Town & Country, 1011 Municipal Center Drive, and at that time will be publicly opened and read. Proposals must be on forms provided. A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal. The proposed work includes:

All work and materials necessary to construct and update a continuous sidewalk from Woods Mill Road to Old Wood Mill Road and install the Post-Construction BMPs as shown on the plans. Work will include existing substandard sidewalk and shoulder removal, t proposed sidewalk, retaining wall, ADA ramps, island cut through, curb and gutter, post construction BMP's, pavement marking, grading, seeding and sodding.

It is the intent of the City of Town & Country for the project to be substantially completed by June 28th, 2013 with minimal "out of service" time.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The prime contractor must be on MoDOT's approved contractor listing. This requirement includes that the contractor has submitted to MoDOT a Contractor Questionnaire *and/or* Contractor Prequalification Questionnaire with attachments no later than seven (7) days prior to the date and hour of the bid opening (see Section 102.2 of the *Missouri Standard Specifications for Highway Construction* for more details). The prime contractor must perform, with its own organization, work amounting to not less than 30% of the total original contract price.

The City of Town & Country hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. **A DBE goal of 20%** has been established for this project. Only the work performed by DBE subcontractors that appear on MoDOT's approved listing at the time of bid opening will be applied towards calculating the DBE goal.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

No 2nd tier subcontracting will be allowed on this project.
The right is reserved to reject any or all bids by the City with MoDOT concurrence.
The contract will be awarded to the lowest, responsive, responsible bidder.
