

NOTICE TO CONTRACTORS NO. 2534

Sealed bids for **COLLEGE STATION PHASE 4 STREETScape**, Plan No. 9PW6216, **CAMPBELL AVENUE & WALNUT STREET TRAFFIC SIGNAL**, Plan No. 7PW5950, and **CAMPBELL AVENUE SOUTH PHASE 1 STREETScape**, Plan No. 2010PW0044T, will be received at Room 106, City of Springfield, Missouri, Busch Building, 840 Boonville Avenue, Springfield, Missouri 65802, until **10:00 A.M. on December 11, 2012** and then publicly opened and read aloud in Room 106 of the Busch Building. Bids received after 10:00 A.M. December 11, 2012, will be returned unopened.

The project consists of the construction of 27,000± SF of 4" slab on grade sidewalk, removal and replacement of approximately 3,400 linear feet of concrete curb and gutter, 1,640 SY full depth street pavement, 2,170 SY asphalt mill and 5,800 SY asphalt overlay, installation of approximately 158 linear feet of reinforced concrete storm pipe with inlets and junction boxes, construction of rain gardens, ornamental street and pedestrian lighting, electrical conduit, and replacement of an existing traffic signal.

A pre-bid conference will be held at **10:00 am, on Tuesday, December 4, 2012**, in Room 106 of the Busch Building. **All Bidders must review the work site and are encouraged to attend the Pre-bid Conference.**

A certified or cashier's check, or bid bond in the amount of five percent (5%) of the bid shall be submitted with each proposal. A Performance Bond on the City's standard forms for the full amount of the contract will be required of the successful Bidder. A Labor and Materials Payment Bond on the City's standard forms for the full amount of the contract will be required of the successful Bidder. The Bidder shall submit a list of subcontractors as specified in the bid documents with its bid.

All labor used in the construction of this public improvement shall be paid a wage of no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate) or the state wage rate, whichever is higher.

The successful Bidder shall comply with certain insurance requirements as specified in the bid documents.

The City reserves the right to reject any and all bids and to waive irregularities in bids.


All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions.

DBE goal for the federally funded portion of this project (Schedule A and Schedule C) has been set at 5%.

Second tier subcontracting will not be permitted on the project.
