An endorsed "Proposal" for construction of Marion County R-II School District Safe Routes to School Sidewalk on portions of State Highway 168 (Front Street) in the City of Philadelphia of Marion County, will be received by the County Commission until 10:00 o'clock A.M. (Prevailing Local Time) on Thursday the 6th day of December, at the office of the County Coordinator of the County Commission and at that time will be publicly opened and read.

The project consists of a new sidewalk construction project and painted crosswalk.

The sidewalk reconstruction project will be constructed in two general areas. The first is on the south side of the highway near the intersection of County Road 13 and extends approximately 177 feet to the west. The second area is located on the north side of the highway starting at County Road 15 extending approximately 787 feet to the east. Work will include the construction of new sidewalks with new concrete pavement including detectable warning surfaces required for accessibility, new cross walk pavement markings, installation of new storm water culvert pipes and school signage along with miscellaneous demolition. There is one Base Bid comprising all of the work west of the centerline of County Road#17 (Sta. 472+46) and two Additive Alternate Bids comprising all work east of this point. Add Alternate 'A' consists of work from County Road#17 (Sta. 472+46) to the east side of driveway at (Sta. 474+21). Add Alternate 'B' will consists of work from the east side of same driveway (Sta. 474+21) to (Sta. 476+37). Base and alternate Bids will bid broken out by pay items.

Special Needs: If you have special needs addressed by the Americans with Disabilities Act, please notify Teya Stice, at the County Coordinator's office, or through Missouri Relay System, TDD 1-800-735-2966, at least five (5) working days prior to the bid opening you plan to attend.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. The DBE goal for this project is 0%.

CONTRACTOR QUESTIONNAIRE: Sec 102.2 of the Missouri Standard Specifications for Highway Construction will be waived for this project.
