**TO ALL PROSPECTIVE BIDDERS:**

The Contract Documents are hereby amended by the following modifications:

- The bid Proposal form has been revised to add bid quantities for grate inlets (#17 NP) and banners (#32). The revised bid Proposal form is enclosed. Staple the revised Proposal form to the original bid Proposal form bound in the Project Manual. Only complete the revised Proposal form.
- The following changes to the bid plans are to be made as part of this Addendum and will be incorporated in final construction plans issued to successful bidder. New versions of the revised plan sheets are included (electronically in PDF form only) with this Addendum. The revised plan sheets can be described as follows:
  - Plan Sheet 3
    - Bid items have been revised to add a bid item (17NP) for Grate Inlet (3'x3') and a bid item (32) for Main Street Banners.
  - Plan Sheet 26
    - Provided clarification that there is NO proposed storm pipe to be installed on north side of Main Street from existing manhole on northeast corner of 13<sup>th</sup> Street intersection to the existing grate inlet near C1 that is to be removed. Linework depicting a pipe in this location was erroneous.
    - Have revised plan note for structure C2 to clarify the location of the existing 2'x2' grate inlet that is to be removed as well as the location of the proposed 3'x3' grate inlet.
- Clarification regarding the following
  - Banner arms on light poles are considered subsidiary to the "Pedestrian Light PP-1" bid item.
- The bid opening is still scheduled for December 13<sup>th</sup>, 2012 as originally advertised.
