Notice to Contractors

Sealed bids for the "Proposal - Polk County Bridge No. 15900031 will be received at: Polk County Commission, 102 E. Broadway, Bolivar, Missouri 65613 until 10:00 o'clock A.M.(Prevailing Local Time) on the 4th day of December, at the office of the Polk County Courthouse, and at that time will be publicly opened and read. All bids shall be submitted Hard Copy.

The proposed work includes: Construction of a 400 foot, four span concrete deck on prestressed concrete I-girders, approach roadway work and any incidental work in accordance with the plans and specifications. The project is located on South 120th Road, Section 1, Township 34 N, Range 23 W, Polk County, Missouri over the Pomme de Terre River. The total length of the improvements is 1,917 feet.

Plans and specifications may be purchased in the offices of Great River Associates, 2826 South Ingram Mill, Springfield, MO 65804, upon payment of \$75.00 for each set for the project, which is not refundable. All checks for plans and specifications are to be made payable to Great River Associates. The plans and specifications will be mailed upon payment of \$25.00 for shipping and handling, for a total of \$100.00 for each set. The shipping and handling charge will be waived if the prospective bidder contacts the Engineer with a valid account number for shipping services such as Federal Express, etc., so that the shipping cost is billed to the bidder.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate for wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The Polk County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Polk County Commission reserves the right to reject any or all bids.

The DBE Goal for this project is 8%.

No 2nd tier subcontracting will be allowed on this project.

The project will be awarded to the lowest, responsive, responsible bidder.
