7. QUESTIONS AND ANSWER PERIOD

Question: Do contractors need to check with utilities prior to installing or excavating for posts?

Answer: Yes. Contractors will be expected to obtain locates for all locations.

Question: What happens if a sign cannot be installed in the specified location due to an unforeseen conflict?

Answer: Slight deviations may be allowed by the inspector. The project will have a full time inspector on site.

Question: How soon from bid opening date will the City issue a notice to proceed?

Answer: The City will endeavor to issue a notice to proceed within 60 days of bid opening date. The project is funded in part by Federal funds administered by the Missouri Department of Transportation. Bids must be approved by MODOT before the City can enter into a contract with the apparent low bidder. Bidders are requested to submit all required documentation even if they are not the apparent low bidder on the day of bid opening. MODOT requires the City to submit bid documentation from the apparent low and second low responsive bidders.
