This contract will include the following project:

Route M (Main Street) Signal Upgrades - All work and materials to construct the Traffic signal upgrades and interconnect: Convert two existing cabinets and controllers to upgraded models, convert two intersections to video detection from loop detection and/or timers. A wireless interconnect will be integrated to eight total traffic signals and connected to existing interconnection. Ramps will be upgraded at intersections to current handicap accessible ramps. New countdown pedestrian signals will be installed or upgraded. Limits are from West Terra to Highway P.

State and Federal wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. The higher rate shall apply for this project. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581; 76 Stat. 357) and implementing regulations.
