Sealed bids for the City of Koshkonong Sidewalk Improvements, will be received at: 305 Luyster Street, Koshkonong, MO 65692, until 10:00 o'clock A.M. (Prevailing Local Time) on the 11th day of October, at the Office of the City of Koshkonong, and at that time will be publicly opened and read. All bids shall be submitted on forms provided.

The proposed work includes:

Excavation and Construction of 3,200 linear feet of 5' wide concrete sidewalk, ADA curb ramps, and any incidental work in accordance with the plans and specifications.

Special Needs: If you have special needs addressed by the Americans with Disabilities Act, please notify Chris Trobaugh, City Clerk, at 417-867-3260, or through Missouri Relay System, TDD 1-800-725-2966, at least five (5) working days prior to the bid opening you plan to attend.

Plans and specifications may be obtained from the GRA plan room at www.greatriv.com upon payment of \$45.00, which is not refundable. All payments are processed online and the contractor is responsible for printing the documents. In addition, all bidders shall be plan holders on the GRA Electronic Plan Room to be eligible to bid.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Koshkonong hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide proof of a 10-Hour OSHA construction safety program training, or similar program approved by the Department of Labor and Industrial Relations, completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Koshkonong reserves the right to reject any or all bids.

No 2nd tier subcontracting will be allowed on this project.
