until 2:00 o'clock P.M. (Prevailing Local Time) on the 5th day of October, at the office of the City of Pleasant Hill, 203 Paul Street and at that time will be publicly opened and read. All bids shall be submitted in the form of sealed bids and the project name must appear on the outside of the bid envelope.

The proposed work includes: Cold milling, resurfacing, reconstructing ADA curb ramps, sidewalk replacement, curb and gutter replacement, and pavement marking.

A nonrefundable certified or cashier's check of \$50.00 made payable to Affinis Corp will be required for bid documents requested by a prospective bidder or any other person. The bid documents shall include one copy of the Project Manual, Contract Documents, and Technical Specification, and one copy of the full-size plans. All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Pleasant Hill hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Pleasant Hill will award this contract to the lowest, responsive and responsible bidder.

The DBE Goal for this project is 7%.

No 2nd tier subcontracting will be allowed on this project.
