Please add the follow to this bid.

- 1) Add under Section 1.3 (Page 8 of 26): Mechanical style sweeper only. Mechanical broom with true conveyor sweeping system that does not use air conveyance to pick up material.
- 2) Add under Section 1.6 (Page 9 of 26): Service All prospective bidders shall have a local manufacturer's authorized and approved service shop that has been open for at least 5 years and have adequate stock of parts, factory trained serviceman capable of furnishing field and shop service and repair parts for the equipment proposed under this bid. Proof shall be satisfied with the City receipt of bidder's authorized service dealer certificate with physical address of local Kansas City Service Center and copies of serviceman certifications of mechanical model sweeper bid. Subcontracting of warranty/service, through another company will not be acceptable. In the best interest of the City of Kansas City, Missouri, the vendor submitting the bid shall be the same servicing vendor performing warranty repairs in the greater Kansas City area. The adequacy and the address of these facilities shall be subject to the approval of the Director of the department requisitioning the equipment, Fleet Maintenance Department and the Manager of Procurement Services.
- 3) Add under Section 1 (Page 10 of 26): Conventional style cab
- 4) Add under Section 6 of Addendum (Page 2 of 17 of Addendum): Factory installed breakaway mirrors to prevent damage to cab while sweeping around trees
- 5) Add under Section 15 of Addendum (Page 12 of 17 of Addendum): Sweeper shall not be equipped with any type of lowering type legs to accomplish dumping. Dumping stability shall be completed by deflating rear air bags and without the use of lowering stabilizers/legs.
- 6) Add under Section 1.3 (Page 8 of 26): Mechanical style sweeper only. Mechanical broom with true conveyor sweeping system that does not use air conveyance to pick up material.
