DESCRIPTION OF WORK OF THIS CONTRACT

The Contract provides for the construction of a three-barrel reinforced concrete triple barrel, low flow box culvert to replace the existing single-span bridge carrying Wild Horse Creek Road over Bates Creek located in Wildwood, Missouri. The project includes associated roadwork, channel work and paving.

BID INFORMATION

Sealed Bids will be received by the City of Wildwood, Department of Public Works (the Owner) until 10:00 A.M., local time, Monday, September 10, 2012. Bids received after this time will not be accepted. Bids will be received at the following location:

Bids will be received on a unit price basis. Bidders shall be qualified to do business and licensed in accordance with all applicable laws of the state and local governments where the Project is located. Bids received from Bidders who are not recorded by Owner as having received the Bid Documents will not be opened. Prequalification of Bidders will be required. Bids received from Bidders who are not prequalified will not be opened. Bid security in the form of a certified or bank cashier's check or a Bid Bond in the amount of 5% of total Bid price shall accompany each Bid in accordance with the Instructions to Bidders. Bids shall be in accordance with the Bid Documents. Bids will be publicly opened and read aloud immediately after time stated above.

COMPLETION

Completion time shall be as follows:

The entire Work shall be completed and ready for final payment in accordance with the GENERAL CONDITIONS within 120 working days after the date when the Contract Time commences to run.

ADDITIONAL PROVISIONS

The City of Wildwood, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

An eleven percent (11%) minimum Disadvantage Enterprise Contract (DBE) participation goal has been established for this contract. No trainee hours are required for this contract.

No 2nd tier subcontracting will be allowed on this project.

The Bid shall be conditioned upon compliance with all labor related requirements including the regulations and stipulations concerning equal employment opportunity, minority manpower utilization, affirmative action requirements, and minimum wage rates.
