A DBE goal of **Zero** percent has been established for this project. All DBE's must be certified and be listed in either the MoDOT DBE Directory or the MRCC DBE Directory.

The prime contractor must perform with his own forces at least 30 percent of the total contract amount.

Sec 102.2 of the Missouri Standard Specifications for Highway Construction will be waived for this project. This is only because this project does not contain roadway or bridge construction, but instead only landscaping, sidewalks, bicycle path, etc.

OSHA –TEN HOUR TRAINING. Missouri Law, 292.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational Safety and Health Administration (OSHA) Construction Safety Program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The awarded contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties, for Non-Compliance include contractor forfeiture to the Missouri Highways and Transportation Commission in the amount of \$2,500, plus \$100 per contractor and subcontractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.

MoDOT and FHWA may make inspections of the work and that the contractor shall grant them access to all parts of the work.

Representatives of MoDOT will make a final inspection on all projects, preferably at the same time as the local agency makes final inspection.
