

INVITATION TO BID

Bridge Replacement Project

Sealed bids for the "Proposal for the Construction of Cedar County Bridge 00300191, BRO-B020(11)" will be received at: Cedar County Commission, 113 South Street, Stockton, MO 65785 until 10:30 o'clock A.M. (Prevailing Local Time) on the 20th day of August, at the office of the Cedar County Courthouse, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes: Construction of a single-span, 45-foot long slab-beam bridge, approach roadway work, paving, and any incidental work in accordance with the plans and specifications. The project is located on County Road 2 (SW 900), in Section 7&18, Township 36N, Range 27W, Cedar County, Missouri, over Little Clear Creek. The total length of the improvements is approximately 872.48 feet.

Plans and specifications may be purchased at the office of the Great River Associates (GRA), at 2826 S. Ingram Mill, Springfield, MO 65804, or purchase online from the GRA plan room at www.greatriv.com upon payment of \$40.00, which is not refundable. All payments are processed online and the contractor is responsible for printing the documents.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The Cedar County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Cedar County Commission reserves the right to reject any or all bids.

The DBE Goal for this project is 0%.

No 2nd tier subcontracting will be allowed on this project.
