SEALED PROPOSALS for the **City of Hallsville, Boone County**, Safe Routes to School project, consisting of:

Work includes the construction of 1,500 linear feet of 6-foot wide concrete sidewalk along an access road through the school property and 2,600 linear feet of 5-foot wide concrete sidewalk along State Highway 124. In addition to the sidewalk construction, the work will include installation of culverts, fencing, and various other structures necessary for the construction of the sidewalk.

WILL be received and opened publicly at the office of City Clerk, 202 East Hwy 124, Hallsville, MO 65255 at 10:00 a.m. on Thursday, July 19, 2012. Any and all bids received after the time specified above will be returned unopened.

A pre-bid meeting will be held at Hallsville City Hall, 202 East Hwy 124, Hallsville, MO at 8:30 a.m. on Tuesday, July 10, 2012. All Bidders are strongly encouraged to attend.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. The higher of the State and Federal Wage Rates prevail. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L. 87-581; 76 Stat. 357) and implementing regulations. **The Contractor shall comply with all requirements with immigration and e-verification of citizenship.**

The Owner hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. The bidder will insure that Disadvantaged Business Enterprises will have the opportunity to participate in the performance of this contract or any subcontracts. The goal for the amount of work to be awarded to DBE's will be 0% of the total contract price.
