Sealed proposals will be received at the Office of the Clerk of the Ste Genevieve County Commission, One Barton Square, Jackson, Missouri 63755, until 10:00 AM CDT on 19 July 2012, for the:

removal of an existing concrete low water crossing over Establishment Creek located on Hennick Road and the construction of a replacement structure consisting of a reinforced concrete deck on concrete end bents. Included in the Work is traffic control, signing, construction and paving of approach roads, embankment protection, concrete, reinforcing bars, seeding and other associated items.

Proposals will be publicly opened and read aloud at on 19 July 2012 at 10:00 AM CDT within the Commission Chambers of the Ste Genevieve County Commission, 55 South 3rd Street, Ste Genevieve, Missouri. All bidders are required to purchase plans and specifications in order to submit a bid for this project.

The Contract provides for the furnishing of all labor, equipment, and materials necessary for the improvement and construction required per the improvement plans, specifications and construction documents.

A certified or cashier's check, or bid bond executed by the bidder and by an approved Surety Company, in the amount of five (5) percent of the bid shall be submitted with each Proposal.

Weekly certified payrolls will be required from the General Contractor and all Subcontractors.
