

# Invitation to Bid

## Mansfield Sidewalk Improvements

Sealed bids for the City of Mansfield Sidewalk Improvements, will be received at: 122 North Business 60, Mansfield, MO 65704, until 10 o'clock A.M. (Prevailing Local Time) on the 16 day of July, at the office of the City Hall , and at that time will be publicly opened and read. All bids shall be submitted on forms provided.

The proposed work includes:

Excavation and Construction of 2,575 linear feet of 5' wide concrete sidewalk and associated curb ramps, drive entry curb, driveway replacements, grading, storm drainage replacements and any incidental work in accordance with the plans and specifications.

Plans and specifications may be at the office of the Great River Associates (GRA), at 2826 S. Ingram Mill, Springfield, MO 65804, or purchase online from the GRA plan room at [www.greatriv.com](http://www.greatriv.com) upon payment of \$45.00, which is not refundable. All payments are processed online and the contractor is responsible for printing the documents. All bidders must be on the GRA Planroom plan holders list to be eligible to bid. In addition, all bidders shall be plan holders on the GRA Electronic Plan Room to be eligible to bid.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Mansfield hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

Sec 102.2 of the Missouri Standard Specifications for Highway Construction will be waived for this project.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide proof of a 10-Hour OSHA construction safety program training, or similar program approved by the Department of Labor and Industrial Relations, completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Mansfield reserves the right to reject any or all bids.

The DBE Goal for this project is: 0%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
