The awarded Contractor and its subcontractor(s) shall requires all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include Contractor forfeiture to the Missouri Highways and Transportation Commission in the amount of \$2,500, plus \$100 per Contractor and sub-contractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.
