

REQUEST FOR BIDS

Kehrs Mill Road Resurfacing and Pedestrian Improvements - STP-5401(630)

City Of Ballwin, Missouri

Sealed bids will be received by the Ballwin City Engineer located at 200 Park Drive, Ballwin, MO 63011-3728 until 10:00 a.m., on July 6, 2012 and then publicly opened and read. All bids shall be submitted on the bid forms provided with the bidding documents.

The proposed work includes: Coldmilling, resurfacing, striping, signing and construction of concrete curb ramps on Kehrs Mill Road between Clayton Road to Holloway Road in the City of Ballwin, including the construction of a new concrete sidewalk with curb ramps along the south side of Kehrs Mill from east of Clayton Road to Lucerne Place and from east of Lucerne Crossing to Holloway Road.

A complete set of the bidding documents are on file for examination at the office of the Engineer, HR Green, Inc. 16020 Swingley Ridge Road, Suite 205, Chesterfield, Missouri 63017. Phone 636-812-4200 to arrange viewing. Copies of the bidding documents may be obtained from the Engineer upon payment of a non-refundable sum of \$50.00 for each complete set. An additional amount of \$20.00 will be charged for mailing of bidding documents.

A Pre-Bid meeting will be held at the Ballwin Public Works Center, 200 Park Drive, Ballwin, Missouri, 63011-3728 at 9:00 A.M. (prevailing local time) on June 29th, 2012.

Each bidder must submit a bid security in the amount of five percent (5%) of their total bid. A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Ballwin hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file seven (7) days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

The City of Ballwin reserves the right to reject any or all bids.

The DBE Goal for this project is 20%.

No 2nd tier subcontracting will be allowed on this project.
