### **Downtown Sidewalk Project Notice to Contractors**

An endorsed "Proposal" for construction or improving Hannibal Main St. Sidewalk and Historic Preservation with Downtown Mill and Overlay on portions of Main St. and selected side streets in Hannibal of Marion County, will be received by the City Clerk until 10:00 o'clock A.M. (Prevailing Local Time) on the 6th day of July, at the office of the City Clerk and at that time will be publicly opened and read.

The project consists of two parts; a sidewalk reconstruction project and a separately funded street pavement mill and overlay project. This project is in the downtown business and tourist district. The Contractor will be required to complete phases and cease construction activities during certain times (Fall Festival in October and Christmas Shopping season are examples of such times).

The sidewalk reconstruction project will improve the streetscape along four blocks of its historic Main Street from Broadway to North Street. The area for this project is within a National Register District. No buildings will be affected. Work will include replacement of existing sidewalks with new concrete pavement including steps and ramps required for accessibility, relocation of street lighting, installation of new directional signage, reconstruct existing storm and sanitary sewer structures, landscaping, downspout trenches, and new sidewalk vault access hatches.


The mill and overlay project will improve the street paving along Main Street from North Street to Broadway, and from Broadway to near Warren Barrett Drive including selected side streets in the downtown area. This project will include milling existing (removal) and replacement of bituminous pavement, limited pavement base reconstruction, replacement of concrete curbs, concrete crosswalks, driveway aprons and pavement markings.

A Pre-Bid Meeting will be held at the Council Chambers at 2:00 P.M. on Wednesday, June 27th, 2012. The meeting is not mandatory, but is highly encouraged due to the complexity of this project. General discussion will occur prior to breakout and tour of Main Street.

Special Needs: If you have special needs addressed by the Americans with Disabilities Act, please notify Mark Edward Rees, PE. City Engineer's office, or through Missouri Relay System, TDD 1-800-735-2966, at least five (5) working days prior to the bid opening you plan to attend.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. The DBE goal for this project is 6%.
