Sealed bids for CITY OF BOLIVAR, MISSOURI – CITYWIDE SAFE PASSAGE PHASE III SIDEWALK will be accepted at the City of Bolivar, 345 S. Main Avenue, Bolivar, MO 65613, until 3:00 P.M., Local Time, on Wednesday, June 20, 2012, and then publicly opened and read aloud. Bids received after 3:00 p.m. will be returned unopened.

The project consists of the construction of erosion and sediment control, traffic control, signage, re-grade ditches, 2,100± S.Y. concrete sidewalk, 1,000 + S.Y. driveway approach/crossings, pavement marking, fine grading, seeding, trickle channel, concrete lined ditch and modular block retaining wall. City Forces will complete a portion of the work including: demolition, removals, earthwork, utility adjustments, storm drainage components, rock blanket, erosion control blanket and barbed wire fence. Refer to Sheet 2 of the plans for a complete breakdown of the work by City Forces and by Contractor.

Copies of the drawings, specifications and other proposed contract documents must be obtained from the Engineer at the office of Olsson Associates, 550 St. Louis Street, Springfield, Missouri 65806 for a non-refundable cost of \$60.00. Any bid received from a contractor whose name does not appear on the list of plan holders at the Office of Olsson Associates, will be subject to rejection. Suppliers and Subcontractors will be classified as Non-Bidders.

Each bidder shall file with his bid a cashier's check, certified check, or a bid bond in the amount of five percent (5%) of the total bid made payable to the City of Bolivar, Missouri.

The bidder to whom a contract is awarded will be required to furnish a performance bond and a payment bond on the forms provided, acceptable to Owner, in the amount of 100 percent of the contract price, in conformity with the requirements of the General Conditions.

The Bidder shall submit a list of subcontractors as specified in the bid documents with its bid.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. The higher of the State and Federal wage rates shall prevail.

The successful Bidder shall comply with certain insurance requirements as specified in the bid documents.

The City reserves the right to reject any and all bids for reasons outlined in the Missouri Standard Specifications for Highway Construction, 2011 Edition, including all revisions. The bid will be awarded to the lowest, responsive, responsible bidder.

Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition, will be waived for this project. Non-MoDOT approved contractors are allowed for this enhancement project.

MoDOT and FHWA shall have the right to inspect work.

OSHA training required per Missouri Law 292.675RSMO.

Second tier subcontracting will not be permitted on the project.
