Notice to Contractors

Sealed bids for STP/BRM-5503(603)_ **Geyer Road Bridge Repair and Widening** will be received at: The City Of Frontenac City Hall 10555 Clayton Road Frontenac Mo,63131 until 10:00 o'clock A.M. (Prevailing Local Time) on the 21st day of June, 2012, and at that time will be publicly opened and read. All bids shall be submitted in the form of a sealed envelope labeled Geyer Bridge, with bidders name and address on front. (Bid forms provided with plan set)

The proposed work includes: The proposed project consists of the removal and replacement of the existing superstructure of the Geyer Road Bridge with a cast-in-place concrete slab supported by spread prestressed concrete voided slab beams; the repair and widening of the Geyer Road Bridge substructure; the construction of a new mixed-use trail bridge consisting of a cast-in-place concrete slab supported by prestressed concrete voided slab beams; the coldmilling and resurfacing of Geyer Road and High Meadow Road, and any incidental work on the above mentioned project. Bridge closure time shall be limited to 60 calendar days.

Any addendum to the plan set will be forwarded to all plan holders.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City Of Frontenac hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

All bidders must be on MoDOT’s Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City Of Frontenac reserves the right to reject any or all bids.

The DBE Goal for this project is 12% . No 2nd tier subcontracting will be allowed on this project.
