and endorsed "Proposal" for constructing the Transportation Enhancement Plan, Phase II, STP-3400(429) City of Windsor, Missouri, will be received by the City until 7:30 o'clock (~~a.m.~~, p.m.), CDT on the 21st day of June, 2012, at the City Hall of the City of Windsor, 110 West Benton Street, Windsor, Missouri and at that time will be publicly opened and read.

The proposed work includes: Construction of approximately 2300 linear feet of varying width concrete sidewalk with ADA ramps, concrete bulb-out islands, landscaping improvements, crosswalk striping, culvert replacement, seeding and mulch along with incidentals.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L. 87-581; 76 Stat. 357) and implementing regulations. When state and federal wage rates are both required, the Contractor shall use the higher of the two for each job classification.

The City of Windsor hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. The bidder will insure that Disadvantaged Business Enterprises will have the opportunity to participate in the performance of this contract and/or any subcontracts. Goals for the amount of work to be awarded to DBE's will be 0% of the total contract price.

Missouri Law, 292.675 RSMO, Requires the awarded contractor and its subcontractor(s) to provide a ten hour Occupational Safety and Health Administration (OSHA) construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (Labors, Workmen, Drivers, Equipment Operators, and Craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The awarded contractor and its subcontractor(s) shall require all such employees to complete this ten hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for noncompliance include contractor forfeiture to The City of Windsor, Missouri in the amount of \$2,500, plus \$100 per calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO
