The project includes: Construction of approximately 3,200 linear feet of concrete sidewalk, 1 crosswalk, one storm sewer structure, 236 linear feet of HDPE Pipe, 14 linear feet of 42" tall handrail and a concrete flume. Concrete sidewalks will be constructed on portions of Market Street, Washington Street, Ridgeway Ave, Eighth Street and Fifth Street.

The BIDDER shall comply with the Disadvantaged Business Enterprise (DBE) Contract Provisions. The goal for the SAINTE GENEVIEVE – SAFE ROUTES TO SCHOOL is 7.00%.

Missouri law, 292.675 RSMO, requires the awarded contractor and its subcontractor(s) to provide a tenhour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri department of labor and industrial relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The awarded contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program.
