Notice to Contractors

Sealed bids for **PROJECT # SRTS-INF-H282 (105), CITY PROJECT # M-11-001**, will be received at 201 S. Franklin St., Kirksville, Missouri until **3:00 P.M.** (Prevailing Local Time) on the **19 day of June, 2012** of the the office of the City Clerk, Kirksville City Hall, and at that time will be publicly opened and read. All bids shall be submitted in the form of a paper bid, completing items in ink or by typing in the information and in a sealed envelope addressed to the CITY OF KIRKSVILLE.

The proposed work includes: **Installation of 11,917 square feet of 4” thick reinforced P.C.C. sidewalk with 4” thick compacted rock base; 5,017 square feet of 6” thick P.C.C. driveways with 6” thick compacted rock base; 12 ADA compliant ramp inserts; 820 SSF decorative block retaining wall; 11,749 square feet of removals of existing sidewalk & driveways; 6,256 square feet of excavation for new sidewalk; 0.495 acres of Dirt Work, seeding, fertilizing & mulching, 6 each of moving or replacing existing plants & planters; 2 Each of Adjust manhole; 120 square feet of Traffic Control.**

Plans and specifications may be picked up from the office of Engineering at City Hall 2nd Floor.

A pre-bid conference will be held at **10:00 AM** on the **12 day of June**, at 201 S. Franklin St., Kirksville, Missouri in the 2nd Floor Conference Room. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The **City of Kirksville** hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The **City of Kirksville** reserves the right to reject any or all bids.

The DBE Goal for this project is 0%.

No 2nd tier subcontracting will be allowed on this project.
