GRG is soliciting sealed bids for construction along the River des Peres corridor from I-55 to Alabama including site work consisting of asphalt trails, concrete flatwork, pavers, concrete barrier wall, storm sewers, concrete and segmental unit retaining wall, cable fencing, ornamental fencing, pedestrian lighting, raingarden and landscape plantings.

Sealed bids will be received at the GRG offices until the Bid Time-Date stated above and immediately thereafter, they will be publicly opened and read aloud. A Bid Security in the form specified in the bidding documents is required. The District with MoDOT concurrence reserves the right to waive informalities in bids and/or to reject any and all bids submitted.

GRG hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. This project includes Disadvantaged Business Enterprise (DBE) Contract Provisions ((49 CFR Part 26) with a 20% Participation Goal and an On-the-Job Training Goal of 1 slot of 1000 hrs (1000 hours total). Project has an OSHA Safety Training requirement.

Prime contractor must have a fully responsive contractor questionnaire on file with the Missouri Highways and Transportation Commission (MHTC) at least seven (7) days prior to the bid opening date. Successful Bidder shall be required to comply in all respects with Federal and State Wage Rates, including applicable statutory provisions concerning payment of prevailing wages on public works projects, Sections 290.210 through 290.340 R.S. Mo. 1959, as currently amended, and shall pay to all workmen performing under work contract not less than prevailing hourly rate of wages as determined by the Department of Labor and Industrial Relations of the State of Missouri. The higher of State or Federal Wage Rates will apply to this project.
