Sealed bids will be received until **10:00 am on Thursday, May 3, 2012**, and then publicly opened and read at **POPLAR BLUFF CITY HALL** for furnishing all labor, materials and equipment and performing all work necessary to: **Place an asphalt overlay on the existing Airport Apron, miscellaneous asphalt improvements as shown on the project plans, and pavement markings on the new overlay and pavement.**

A pre-bid conference for this project will be held at **10:00 am on Wednesday April 25 at the Poplar Bluff Airport.**

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to **City of Poplar Bluff**.

Bids may be held by the **City of Poplar Bluff, Missouri** for a period not to exceed **60 DAYS** from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as the **City of Poplar Bluff, Missouri** may require, to reject any bid and also the right to reject all bids.

In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in accordance with the schedule of wage rates established by the United States Department of Labor and the Missouri Division of Labor Standards, respectively. The highest rate between the two (Federal and State) for each job classification shall be considered the prevailing wage.

This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise Participation. The owner has established a contract goal of **0%** percent participation for small business concerns owned and controlled by certified disadvantaged business enterprises (DBE). The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet the established goal.

Award of contract is also subject to the following Federal provisions:
