

NOTICE TO BIDDERS

Sealed bid proposals endorsed "Proposal For Construction of Sidewalk Improvements", addressed to the Clever R-V School District and the City of Clever, Missouri, c/o the City of Clever, P.O. Box 52, 304 South Clarke, Clever, Missouri 65631, will be received by the Clever R-V School District and the City of Clever until **11:00 a.m., Prevailing Local Time, on MAY 8, 2012** at the Clever City Hall, 304 S. Clarke, in Clever, Missouri and at that time will be publicly opened and read aloud. The proposed work generally includes the following:

Construction of 5' wide sidewalk, access ramps, culverts, and any incidental work related thereto in accordance with the plans and specifications. The project is generally located in various locations in the City of Clever, Christian County, Missouri. The total length of the improvements is approximately 7,305 feet.

Wage rates paid on construction work for this project shall be at least equal to the prevailing wage rates as specified in the contract documents and specifications. When Federal Wage rates are applicable and included, this contract is subject to the "Wage Hours Act of 1962" (P.L. 87-581; 76 Stat. 357) and implementing regulations.

The Clever R-V School District and the City of Clever hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry or national origin in consideration for an award. The bidder will insure that Disadvantaged Business Enterprises will have the opportunity to participate in the performance of this contract and or any subcontracts. Goals for the amount of work to be awarded to DBE's will be 0%.

Bidders are informed that all contractors are subject to full compliance with all applicable laws, ordinances, rules and regulations, and the requirements of the Equal Opportunity Act and it is not the intent of the owner to arbitrarily dismiss any authorities.

Plans and specifications may be obtained at the offices of Anderson Engineering, 2045 West Woodland, Springfield, Missouri, upon payment of a submission of a non-refundable deposit of \$50.00 for each set. Additional shipping and handling expenses are applicable and the responsibility of the bidder. Checks for plans, specifications and shipping are to be made payable to Anderson Engineering, Inc..

The character and amount of security to be furnished by bidders is stated in the contract documents mentioned above. Each bidder shall file with his bid a bidder's bond as indicated per the contract documents. The bidder to whom a contract is awarded will be required to furnish a performance bond and a payment bond on the forms provided, payable to the Clever R-V School District and the City of Clever, and in the amount of 100 percent of the contract price in conformity with the requirements of the General Conditions

Proposals must be on forms provided and all unit price bids, extensions and total provided thereon shall be completed fully. The right is reserved to waive any informalities and reject any or all bids.

No bidder may withdraw his bid within 60 days after the actual date of the opening thereof.
