

NOTICE TO BIDDERS

Sealed proposals addressed to the City of Marshfield, 798 S. Marshall, Marshfield, MO 65706, and endorsed "***SIDEWALK IMPROVEMENTS – PHASE 2***" , STP-9900(835) will be received by the City of Marshfield, Missouri, until 10:00 o'clock a.m., prevailing local time, on March 22nd, 2012 at City Hall, 798 S. Marshall, Marshfield, MO, and at that time, will be publicly opened and read.

The proposed work includes:

Approximately: 28,765 s.f. of concrete sidewalk, driveway removal & replacement excavation, finish grading and miscellaneous work.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962" (P.L. 87-581; 76 Stat. 357) and implementing regulations. By virtue of statutory authority, preference shall be given on other than Federal Aid Projects to materials, products, supplies, provisions, and other articles produced, manufactured, made, or grown within the State of Missouri where same are of a suitable character and can be obtained at reasonable market prices in the State and are of a quality suited to the purpose intended and can be secured without additional cost over foreign products or products of other states.

The City of Marshfield hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award

The Disadvantaged Business Enterprise (DBE) goal for this project is 0% and shall meet the requirements of 49 CFR Part 26. Federal funds will be used to assist in the development of this project. The DBE submittal forms shall be completed and submitted with the bid proposal or delivered by the low and second low bidder within three working days after the bid opening date.

The project shall be substantially completed within 120-calendar days.

Bidders are informed that all contractors are subject to full compliance with all applicable laws, ordinances, rules and regulations, and the requirements of the Equal Opportunity Act as it is not the intent of the owner to arbitrarily dismiss any authorities.
