

## INVITATION TO BID

Sealed proposals for the improvements of the HANNA ROAD BRIDGE REPLACEMENT, will be received by the CITY OF VALLEY PARK, Valley Park, Missouri, at City Hall office located at 320 Benton Avenue on **March 15, 2012, at 11:00 A.M.** and will be publicly opened and read aloud. Bids received after said time will be returned unopened. **All bids shall be submitted in triplicate in an envelope marked "CITY OF VALLEY PARK – HANNA ROAD BRIDGE REPLACEMENT"**

The proposed work includes the furnishing of materials, tools, equipment and labor necessary for the installation of a 74' single span bridge with 5' walkway, 32' roadway width and reconstruction of approximately 0.65 miles of roadway, including installing sidewalk and installation of new storm sewers in accordance with the plans and specifications and other items identified in the contract documents. The contractor is responsible for all items of work necessary to complete the project.

Copies of the plans and specifications may be obtained from WEIS DESIGN GROUP, 16296 Westwoods Business Park Dr., Ellisville, MO. 63021. The plans and specifications are non-refundable and are One Hundred Dollars (\$100.00) for each set.

Each bid must be accompanied by a cashier's check or certified check, or a Bid Bond executed by the BIDDER and an approved surety company and payable to the CITY, in an amount not less than five percent (5%) of the sum total of the base bid.

Not less than the prevailing hourly rates of wages as found by State or Federal Wage Rates, whichever is higher, or determined by court on appeal, shall be paid to all workers performing work under this Contract.

The DBE goal for this letting is a minimum 18% of the total contract amount.

A prime contractor must have a fully responsive contractor questionnaire on file with the MHTC at least seven (7) days prior to the bid opening date if this project involves roadway or bridge work. All BIDDERS must meet the MoDOT requirements as a CONTRACTOR prior to bid opening in accordance with the Missouri Standard Specification Book for Highway Construction.

A Performance Bond and Payment and Materials Bond are required.

No bid may be withdrawn within thirty (30) days after the scheduled closing time for receipt of bids.

The City of Valley Park hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement will be awarded to the lowest, responsive, responsible bidder and any disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The bidder, having examined and being familiar with the local conditions affecting the work, and the contract, contract documents, including the Missouri Highways and Transportation Commission's "Missouri Standard Specification for Highway Construction, 2011; effective date: June 1, 2011" and "Missouri Standard Plans for Highway Construction, 2009", their revisions, and the request for bid, including appendices, the special provisions and plans, hereby proposes to furnish all labor, materials, equipment, services, etc., required for the performance and completion of the work. All references are to the Missouri Standard Specifications for Highway Construction, as revised, unless otherwise noted.

Bidders are informed that pursuant to Section 285.530, RSMo, as a condition of the award of any contract in excess of five thousand dollars (\$5,000.00), the successful bidder shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection to the contracted services. Successful bidders shall also sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection to the contracted services.

Missouri law, 292.675 RSMo, requires the Contractor and its subcontractor(s) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The Contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMo, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include Contractor forfeiture to the City of Valley Park in the amount of \$2,500, plus \$100 per contractor and subcontractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMo.
