INVITATION TO BID

Sealed bids for **CITY OF AVA, MISSOURI – WALK THIS WAY PHASE III SIDEWALK** will be accepted at the City of Ava, 127 SW 2nd Street, P.O. Box 967, Ava, Missouri 65608, until **10:00 A.M., Local Time, on March 8, 2012** and then publicly opened and read aloud. Bids received after 10:00 am will be returned unopened.

The project consists of the construction of earthwork, erosion and sediment control, demolition, clearing and grubbing, 2000 ± S.Y. concrete sidewalk, pavement marking, signage and modular block retaining wall.

Copies of the drawings, specifications and other proposed contract documents must be obtained from the Engineer at the office of Olsson Associates, 550 St. Louis Street, Springfield, Missouri 65806 for a non-refundable cost of \$60.00. Any bid received from a contractor whose name does not appear on the list of plan holders at the Office of Olsson Associates, will be subject to rejection. Suppliers and Subcontractors will be classified as Non-Bidders.

Each bidder shall file with his bid a cashier's check, certified check, or a bid bond in the amount of five percent (5%) of the total bid made payable to the City of Ava, Missouri.

The bidder to whom a contract is awarded will be required to furnish a performance bond and a payment bond on the forms provided, acceptable to Owner, in the amount of 100 percent of the contract price, in conformity with the requirements of the General Conditions.

The Bidder shall submit a list of subcontractors as specified in the bid documents with its bid.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. The higher of the State and Federal wage rates shall prevail.

The successful Bidder shall comply with certain insurance requirements as specified in the bid documents.

The City reserves the right to reject any and all bids for reasons outlined in the Missouri Standard Specifications for Highway Construction, 2011 Edition, including all revisions. The bid will be awarded to the lowest, responsive, responsible bidder.

Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition, will be waived for this project. Non-MoDOT approved contractors are allowed for this enhancement project.

MoDOT and FHWA shall have the right to inspect work.

OSHA training required per Missouri Law 292.675RSMO.

Second tier subcontracting will not be permitted on the project.
