Astra Way & MO State Road STP-5403(626)

Notice is hereby given that sealed bids for an endorsed "Proposal" for construction or improving the following routes and projects in the City of Arnold will be received by the City Clerk, Arnold City Hall, 2101 Jeffco Blvd., Arnold, Missouri 63010, until 3:00 p.m., (Prevailing Local Time) Tuesday, January 17, 2012, at which time the bids will be publicly opened and read. Two (2) hard copies of the bid documents must be submitted in a sealed envelope marked "MO State Road& Astra Way" in the lower left corner.

The proposed work includes: Grading, paving, drainage, signage, lighting, marking and sidewalk construction necessary for the construction of a roundabout at the intersection of Astra Way Drive and Missouri State Road. The work shall be in accordance to these Specifications, Job Special Provisions, as well as the project plans. Where not specifically covered by the Specification or Job Special Provision, the Contractor shall adhere to the 2011 Edition of the "Missouri Standard Specifications for Highway Construction".

This project is being bid concurrently with the adjacent roadway improvement project - STP-5403(614) "Missouri Rte 141 & Astra Way". The two projects, STP-5403(614) & STP-5403(626), shall be awarded to the single responsive bidder having the lowest summation of "COMBINED BID" listed in the Bid Tab.

Special Needs: If you have special needs addressed by the Americans with Disabilities Act, please notify Bryson Baker, at 636-282-2386 at least five (5) working days prior to the bid opening you plan to attend.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the plan appendices. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations.

MoDOT has set a DBE (Disadvantaged Business Enterprise) goal of 15% for this project.

The City hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
