

INVITATION FOR BIDS

Sealed Bids for **Natural Bridge Road at Edmundson Road Intersection Improvements** will be received by the City Clerk, City of Edmundson, 4440 Holman Lane, Edmundson, Missouri 63134, until **10:00 a.m.**, (prevailing central time) on **December 5, 2011** and will thereafter be publicly opened and read aloud.

The proposed work includes the furnishing of materials, tools, equipment and labor necessary to construct intersection Improvements at Natural Bridge Road and Edmundson Road, Federal Project # STP-7303(612), St. Louis County, Missouri

Work includes the construction of a new eastbound right turn lane and new sidewalks along Natural Bridge Road between Airflight Drive to Edmundson Road. The project includes grading, drainage, paving, signing, striping, sidewalks, and traffic signal modifications.

Plans and specifications may be obtained on and after **November 8, 2011** for a **\$50** non-returnable fee at the City Hall, City of Edmundson, 4440 Holman Lane, Edmundson MO 63134. Questions should be directed to Chuck Nunn, Public Works Director, at (314) 428-7125. Plan sets will be mailed upon request for a non-returnable fee of **\$75** after a check is received. Make all checks payable to "**City of Edmundson**."

All requests for clarifications on these bidding documents must be received in writing at least one week prior to the bid opening.

Each bid must be accompanied by a cashier's check or certified check, or a Bid Bond executed by the BIDDER and an approved surety company and payable to the CITY, in an amount not less than five percent (5%) of the sum total of the base bid.

Not less than the prevailing hourly rates of wages as found by Federal Wage Rates, or determined by court on appeal, shall be paid to all workers performing work under this Contract.

The DBE goal for this letting is a minimum <u>18%</u> of the total contract amount.

All BIDDERs must meet the MoDOT requirements as a CONTRACTOR at least seven days prior to bid opening in accordance with Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011.

A Performance Bond and Payment and Materials Bond are required.

The CITY plans to award the contract to the lowest, responsive, responsible bidder.

The CITY reserves the right to reject any and all Bids, to waive informalities therein, and to approve the bond. No Bid may be withdrawn for a period of sixty (60) days subsequent to the specified time for receipt of Bids.

The CITY intends to issue the Notice to Proceed on or about February 15, 2012.

The City of Edmundson hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
