Indicate the role your key personnel played in the projects and include reference contact information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

MoDOT will evaluate firms based on: Concept Innovation, Successful Past Performance, Qualifications of Personnel Assigned, Commitment to a Diverse Workforce and Familiarity/Accessibility of Firm and Staff.

We request all letters be received by 3:00 pm, January 18, 2013 at the appropriate office.
