The Missouri Highways and Transportation Commission is requesting the services of a consulting engineering firm to perform the described professional services for the project included on the attached list.



It should also include any other information which might help us in the selection process, including key personnel you would assign to the project and the backgrounds of those individuals, and any sub-consultants you would propose to use. We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information. In addition, please attach one page with detailed information on similar projects that your key personnel have worked on. Indicate the role your key personnel played in the projects and include reference contact information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

MoDOT will evaluate firms based on: Past Performance, Qualifications of Personnel Assigned, Familiarity/Capability, General Experience of Firm, and Accessibility of Firm and Staff.

We request all letters be received by 3:00 pm, January 25, 2013 at the appropriate office.

Length:	The proposed new bridge is approximately 430 ft. long with a 24 ft. roadway width.

Other Comments:	<p>100% unsigned and unsealed bridge plans are due to MoDOT by August 26, 2013. Final electronic signed and sealed bridge plans and JSP's must be submitted to MoDOT's Design Division by September 16, 2013.</p> <p>Preliminary Bridge Design: MoDOT has already completed the preliminary bridge design through the bridge memorandum stage. MoDOT has also completed a geotechnical report for the structure. The selected Consultant will be expected to determine the final foundation types based on the geotechnical report and then create the Design Layout along with completing the preliminary plans and preliminary bridge cost estimate. No hydraulic analysis work will be required.</p> <p>Consultant will need to coordinate directly with the Kansas City District regarding any roadway design questions.</p> <p>No interviews – due to the short timeframe, it is anticipated that selection will be made within two weeks.
